## REFUND POLICY

The North Vancouver Community Arts Council reserves the right to cancel any class which does not meet a minimum enrollment prior to the start date. In the event of class cancellation, students will be notified by phone and/or email. If a class is cancelled by The North Vancouver Community Arts Council, a full refund will be given.

### Withdrawals

Withdrawals from classes, camps and workshops is permitted up to five business days prior to the start of the class. All refunds are subject to an administration fee of 20% of the class fee or \$10 (whichever is greater). All withdrawals or requests for transfers MUST be made through the NVCAC Office by contacting programmes@nvcacouncil.ca or 604.988.6844. Students cancelling fewer than five business days before the start of class will not receive a refund (exemptions made for medical reasons accompanied by a doctor's note.) The NVCAC is not responsible for classes missed by the student. Missed classes cannot be transferred, made-up, or carried to other sessions.

### Late Registration

Provided that there is still space in a class, registration is accepted after the first class has already taken place. There will be no discount given to participants who register late.

## WAIVER RELEASE STATEMENT

### Notice to Parent/Guardian

It is a condition to the Child's participation in the Activity that you, the undersigned Parent/Guardian of the Child, must carefully read and understand this document and check below to acknowledge that you have read and understand it and that you understand that the Child's participation in the activity will expose the Child to risks of harm and that you accept full responsibility for exposing the Child to such risks.

### Parent/Guardian Responsibility for Child

I, the stated Parent/Guardian of the Child, understand and accept that, in respect of the Child's participation in the Activity, it is my responsibility (1) to ensure that I consider and understand the risks, dangers, hazards and consequences of injury inherent in the Activity, (2) to determine, taking into consideration those risks and the Child's behavioural characteristics, physical health and abilities, whether the Child should be allowed to participate in the Activity, (3) to ensure that the Child is appropriately covered by medical insurance for any harm occurring in the Activity.

I AM THE PARENT AND/OR LEGAL GUARDIAN OF THE CHILD AND HEREBY CONSENT TO HIM OR HER PARTICIPATING IN THE ACTIVITY, AND, FOR MYSELF AND THE CHILD, IN RETURN FOR THE NVCAC ALLOWING THE CHILD TO PARTICIPATE IN THE ACTIVITY:

- 1) I now waive all legal rights to sue and any and all claims which I or the Child or our respective successors and assigns may have against the NVCAC in connection with any loss, injury, damage or expense that I or the Child may suffer, incur or may suffer, incur or experience in connection with the Child's participation in the Activity; and
- 2) I hereby release the NVCAC from any and all liability for any complaints, demands, claims, actions, suits, judgments and orders for any and all losses, injuries, damage or expenses I or the Child may suffer, incur or experience in connection with the Child's participation in the Activity; and
- 3) For myself, I agree to indemnify the NVCAC for and hold it harmless from any and all losses, injuries, damages and expenses of any kind that the NVCAC may suffer, incur or experience and for any and all complaints, demands, claims, actions, suits, judgments and orders for any and all losses, injuries, damages or expenses of any kind anyone else may suffer, incur or experience in connection with the Child's participation in the Activity.
